Applications postmarked between **March 16 & March 22, 2010 - \$100 USD**

Application requirements include:

- 1) completion of the repertoire form & CDs as specified below.
- 2) submission of the online application, which can be accessed at www.concertartists.org/competition.htm
- 3) payment of the application fee.

APPLICATION FEE: The fee may be paid through PayPal online at www.concertartists.org/competition.htm or by check or money order (payable to Concert Artists Guild and enclosed with CDs and repertoire form).

CASH OR FOREIGN CHECKS WILL NOT BE ACCEPTED.

REPERTOIRE FORM: You must include **THREE IDENTICAL COPIES** of this form. **WRITE YOUR NAME AT THE TOP OF THIS PAGE. DO NOT PUT YOUR NAME IN ANY OTHER PLACE ON THIS FORM.**

CD SPECIFICATIONS: The entire program must be recorded on one CD. CAG must receive **TWO IDENTICAL RECORDINGS**. Recordings must be live and unedited, except for long pauses, applause and lengthy musical introductions, which **MUST** be edited out. DVDs, TAPES, LPs, DATS, and MINIDISCS will not be accepted. Review your materials before you send them. Blank listening materials will result in disqualification.

LABELING YOUR RECORDINGS: You may label the CDs with the cutout-label download on CAG's website. If you use your own insert, **DO NOT put**

your name on your recordings. Include your category and list the repertoire recorded on your submission.

REPERTOIRE GUIDELINES

FOR ALL APPLICANTS: 30-45 minutes of music in a variety of styles and periods. No specific works or composers are required. However, the CDs must demonstrate the breadth of your technical and artistic abilities. A work composed since 1990 is not required for the Preliminary Round (CD). **You may repeat repertoire in later rounds.**

INSTRUMENTALISTS: Include only complete works or complete movements. Concerti or other works with orchestra may be included. These works may also be performed with piano accompaniment, except for solo pianists.

SINGERS: Include selections in at least 3 languages, one of which must be English. You may submit individual songs; complete cycles are not required. There is no aria requirement, and no more than two may be included.

SPECIALISTS: Specialists in contemporary, early or non-traditional music may apply. Repertoire must show programmatic diversity & technical scope.

NON-TRADITIONAL INSTRUMENTALISTS are invited to apply. CAG would welcome a statement of purpose and information on repertoire and technical requirements, if appropriate.
